- Institute is encouraging the policy of minimizing the use of plastic in the institute premises. Usages of plastic cups are completely banned in college canteens and mess.
- The green and environmental awareness would be spread to the nearby community as student's extension activities.

Practices

- In order for green environment and clean campus, a gardener and adequate supporting staffs have been appointed. All the departments and classrooms are provided with dustbins for dry waste disposal. Green audit is conducted to identify, quantify, and prioritize frame work for environmental sustainability.
- The institute as good storage of ground water, drinking water and water for cleaning purposes. The college as rainwater harvesting pits, check dams for ground water recharge.
- Digitalisation of documents is one such measure where in the technology is used to a great extent for communication among staff and students. WhatsApp class wise groups, Department wise groups etc. Facilitate E communication there by reducing usage of papers.
- The college conducts awareness programmes for staff, students and society for protecting and maintaining environment.
- A range of medicinal plants and old trees like Neem trees etc. makes the campus rich in oxygen.
